DEBTORS MOTION FOR AN ORDER PURSUANT TO SECTIONS 365 AND 544 OF THE BANKRUPTCY CODE AUTHORIZING REJECTION OR **ABANDONMENT OF CERTAIN AIRCRAFT**

Northwest Airlines Corporation ("NWA Corp.") and certain of its direct and indirect subsidiaries, as debtors and debtors in possession (collectively, the "Debtors"),1 respectfully represent:

¹ Specifically, in addition to NWA Corp., the Debtors consist of: NWA Fuel Services Corporation ("NFS"), Northwest Airlines Holdings Corporation ("Holdings"), NWA Inc. ("NWA Inc."), Northwest Aerospace Training Corp. ("NATCO"), Northwest Airlines, Inc. ("Northwest Airlines"), MLT Inc.

SUMMARY OF RELIEF REQUESTED

Debtors operate a diverse fleet of commercial aircraft², many of which are 1 subject either to secured debt or lease financing arrangements. The Debtors are analyzing their flight schedules and aircraft fleet, the projected demand for air travel, maintenance requirements, labor costs, operating costs and other business goals and objectives. Through this analysis the Debtors intend to (i) rationalize costs relating to aircraft lease and debt obligations and (ii) match the aircraft fleet to future operating needs. Although this analysis is continuing, the Debtors have already identified certain aircraft under existing lease or debt terms which are not of benefit to the estates. These aircraft include (i) certain aircraft which have been stored for an extended period of time (the "Parked Aircraft") and (ii) certain aircraft that because of their age, ongoing expected costs and current expectations as to future operations are no longer providing value to the estates (the "Surplus Aircraft"). The Parked Aircraft and the Surplus Aircraft are collectively hereinafter referred to as the "Excess Aircraft". Accordingly, the Debtors request entry of an order pursuant to sections 365 and 544 of the Bankruptcy Code, authorizing the Debtors (a) to reject, effective as of today, the leases for such of the Excess Aircraft as are leased and (b) to abandon, effective as of today, such of the Excess Aircraft as are owned, subject to secured debt obligations. The Excess Aircraft to be returned by the Debtors pursuant to this motion are identified in Exhibit A.³

("MLT"), Northwest Airlines Cargo, Inc. ("Cargo"), NWA Retail Sales Inc. ("NWA Retail"), Montana Enterprises, Inc. ("Montana"), NW Red Baron LLC ("Red Baron"), Aircraft Foreign Sales, Inc. ("Foreign Sales"), and NWA Worldclub, Inc. ("WorldClub").

² For purposes of this motion, the term aircraft includes both airframes and engines.

³ It is possible that some of the leases that are the subject of this motion could be recharacterized as financing arrangements. However, because the Debtors are requesting relief under both Sections 365 and 544 of the Code, the motion does not require a determination of whether any particular lease is a true lease. Accordingly, the Debtors are not placing that issue before the Court, and nothing in this motion is intended to be an admission by the Debtors that any particular lease is a true lease.

2. The Debtors are also reviewing their fleet needs to identify aircraft that, under existing lease or debt terms, are not of benefit to the estates, but which, if the lease or debt terms were revised, could be of benefit to the estates (the "Potential Excess Aircraft"). The Debtors have already identified an initial group of Potential Excess Aircraft, which are identified in Exhibit B. As to these aircraft, some of which are leased and some of which are owned, the Debtors request authority to file a notice of rejection or abandonment not later than 45 days from the Petition Date. During this 45-day period, Debtors will attempt to renegotiate the terms of the relevant leases and debt financings.

JURISDICTION

3. This Court has jurisdiction to consider this Motion pursuant to 28 U.S.C. §§ 157 and 1334. This matter is a core proceeding pursuant to 28 U.S.C. § 157(b)(2). Venue is proper in this Court pursuant to 28 U.S.C. §§ 1408 and 1409.

BACKGROUND

- 4. On the date hereof (the "Petition Date"), each of the Debtors filed with this Court a voluntary petition for relief under chapter 11, title 11, United States Code, 11 U.S.C. §§ 101, *et seq.* (the "Bankruptcy Code"). Each Debtor is continuing to operate its business and manage its properties as a debtor in possession pursuant to sections 1107(a) and 1108 of the Bankruptcy Code.
- 5. Simultaneously with the filing of this pleading, the Debtors have filed a motion with this Court pursuant to Rule 1015 of the Federal Rules of Bankruptcy Procedure seeking joint administration of the Debtors' estates.
- 6. No creditors' committee has yet been appointed in these cases. No trustee or examiner has been appointed.

THE DEBTORS⁴

- 7. NWA Corp., Holdings and NWA Inc. NWA Corp. is the parent corporation of Holdings which, in turn, is the parent corporation of NWA Inc. NWA Inc. is the parent corporation of Northwest Airlines and the indirect parent corporation of the other Debtors (as well as certain non-Debtor entities).
- 8 Northwest. Northwest Airlines, together with the other Debtors, operates and manages a consolidated global business with employees, assets and creditors located all over the world (such business, "Northwest"). Northwest, which began operations in 1926, today operates the world's fourth largest airline (as measured by revenue passenger miles). For the fiscal year ended December 31, 2004, Northwest had operating revenues of \$11,279,000,000. As of June 30, 2005, Northwest had approximately 39,000 employees, operated a fleet of 433 aircraft and directly served (together with its regional carriers) more than 232 destinations in 25 countries in North America, Asia and Europe. Together with its SkyTeam alliance and its other travel partners, Northwest provides a global network to over 900 cities in more than 160 countries on six continents.
- 9 Northwest has domestic hubs at Detroit, Minneapolis/St. Paul and Memphis, and international hubs in Tokyo and Amsterdam. Northwest is party to a transatlantic joint venture with KLM Royal Dutch Airlines ("KLM"), has domestic and international alliances with Continental Airlines, Inc. ("Continental") and Delta Air Lines, Inc. ("Delta"), and is a

- of the Americas, 6th floor, New York, New York, operates a jet fuel supply and trading business. In the course of its business, NFS purchases jet fuel directly from numerous fuel suppliers and supplies the fuel to Northwest and to other airlines. NFS supplies fuel directly to Northwest Airlines' operations at airports by truck. In addition, NFS arranges for fuel to be shipped through common carrier pipelines across the United States to various third party storage facilities located in proximity to Northwest Airlines' major terminal hubs. NFS primarily relies upon revenues obtained from Northwest Airlines to sustain its business operations.
- 11. MLT is among the largest vacation wholesale companies in the U.S. MLT develops and markets Worry-Free Vacations that include air transportation, hotel accommodations, car rentals, ground transportation and/or leisure activities. In addition to its Worry-Free Vacations charter program, MLT develops, markets and supports Northwest's WorldVacations travel packages to destinations throughout the U.S., Canada, Mexico, the Caribbean, Europe and Asia, with air transportation provided primarily on Northwest and/or its codeshare partners. During the fiscal year ended December 31, 2004, MLT had revenues of \$469,000,000.
- 12. <u>NATCO</u>. NATCO provides training and aircraft simulation services primarily to pilots for Northwest. NATCO makes all unused time available for sale by a third party to other airlines, governments and corporations. The NATCO training facility includes 18

full-flight simulators and four fixed-base training devices. In 2004, NATCO had approximately \$3,565,000 in revenue from the sale of idle time.

RELIEF REQUESTED AND REASONS THEREFOR

- 13. As of September 1, 2005, Northwest had a fleet of approximately 699 aircraft, consisting of 381 narrow-body, 84 wide-body aircraft (including 14 Boeing 747 freighter aircraft), and 234 regional aircraft. The Debtors' need to adjust the fleet size and mix in light of current market conditions for aircraft, projected demand for air travel, current and projected flight schedules, maintenance requirements, labor costs, and other business and economic factors.
- 14. The Debtors' fleet review process is not complete, is inherently dynamic and is expected to result in additional aircraft being returned to lessors and lenders in order to match fleet requirements with current market dynamics. The Debtors estimate that more than 100 aircraft in the aggregate will be designated for deletion from the fleet. As of today, the Debtors have determined that it is not in the best interest of the estates to retain the Excess Aircraft identified on Exhibit A. Some of these aircraft are in storage, and have been for some time (the Parked Aircraft). These aircraft are generating no value for the Debtors and play no role in the Debtors' future plans. The balance of the aircraft listed on Exhibit A (the Surplus Aircraft) have been recently taken out of service due to their age, maintenance condition, and ongoing expected costs and play no role in the Debtor's future plans.
- 15. The Excess Aircraft are either (a) the subject of leases with various lessors or (b) owned and subject to a mortgage or other debt financing arrangement with various lenders. Accordingly, by this Motion, the Debtors respectfully seek an order (a) authorizing the rejection, effective as of today, of the leases relating to the Excess Aircraft pursuant to Section 365 of the Bankruptcy Code and (b) authorizing the abandonment, effective as of today, of the owned

Excess Aircraft pursuant to Section 544 of the Bankruptcy Code. Immediately upon the entry of an order granting this motion, the Debtors will make the Excess Aircraft available for delivery to the related lessors and related lenders, as applicable, at the locations indicated on Exhibit A.

- Excess Aircraft, which are listed on Exhibit B. Under existing lease or debt terms, the Potential Excess Aircraft are not of benefit to the estates. However, given the types and ages of these aircraft, the Debtors could benefit from these aircraft if the lease or debt terms, as applicable, were revised. By this Motion, the Debtors respectfully seek an order (a) authorizing the rejection of the leases relating to the Potential Excess Aircraft pursuant to Section 365 of the Bankruptcy Code and (b) authorizing the abandonment of the owned Potential Excess Aircraft pursuant to Section 544 of the Bankruptcy Code. Rather than being effective as of the petition date, however, the Debtor requests that the rejection or abandonment, as applicable, becomes effective as to each aircraft at the time that the Debtors file with the Court a rejection or abandonment notice. Such notices would be filed with the Court, upon the sole discretion of the Debtors, at any time, but not later than 45 days from the Petition Date. During this 45-day period, Debtors would attempt to renegotiate the terms of the relevant leases or debt financings.
- Debtors to the affected lessors and lenders, the Debtors will maintain the current insurance coverage and continue the existing storage maintenance program pursuant to the Debtors FAA-approved maintenance program relating to the Excess Aircraft until the earlier of: (a) the thirtieth (30th) day after the Petition Date or (b) the date on which the lessor or mortgagee takes possession of such Excess Aircraft (the "Coverage Period"). The Debtors will do the same with respect to the Potential Excess Aircraft for which a notice of rejection or abandonment is filed, except that the Coverage Period shall be the earlier of (a) the thirtieth (30th) day after the date on

which the notice of rejection or abandonment is filed with the Court or (b) the date on which the lessor or mortgagee takes possession of such Potential Excess Aircraft. At the conclusion of the Coverage Period, the Debtors shall cease insuring and maintaining the aircraft.

18. To the extent that any of the Excess Aircraft or Potential Excess Aircraft is subleased out by the Debtors to its regional carriers, the Debtors are also moving to reject the subleases. The rejection of a prime lease automatically terminates the right to possession under the sublease. The rejected subleases, if applicable, are also set forth on Exhibit A.

REJECTION UNDER SECTION 365 OF THE BANKRUPTCY CODE IS IN THE BEST INTERESTS OF THE ESTATE

- 19. Section 365(a) of the Bankruptcy Code provides that a debtor in possession "subject to the court's approval, may assume or reject any executory contract or unexpired lease of the debtor." 11 U.S.C. § 365(a). The United States Court of Appeals for the Second Circuit has stated that "[t]he purpose behind allowing the assumption or rejection of executory contracts is to permit the trustee or debtor in possession to use valuable property of the estate and to 'renounce title to and abandon burdensome property." Orion Pictures Corp. v. Showtime Networks, Inc. (In re Orion Pictures Corp.), 4 F.3d 1095, 1098 (2d Cir. 1993) (quoting 2 Collier on Bankruptcy ¶ 365.01[1] (15th ed. 1993)).
- 20. In considering a motion to assume or reject a contract or lease, the court "should examine a contract and the surrounding circumstances and apply its best 'business judgment' to determine if [the contract or lease] would be beneficial or burdensome to the estate." Orion, 4 F.3d at 1099; see also Nostas Associates v. Costich (In re Klein Sleep Products, Inc.), 78 F.3d 18, 21 (2d Cir. 1996); In re Balco Equities Ltd, Inc., 323 B.R. 85, 99 (Bankr. S.D.N.Y. 2005) ("In determining whether the debtor has employed reasonable business discretion, the court for the most part must only determine that the rejection will likely benefit

the estate."); <u>In re Penn Traffic Co.</u>, 322 B.R. 63, 68 (Bankr. S.D.N.Y. 2005) ("It is well established that the decision whether to assume or reject an executory contract under section 365(a) is a matter of business judgment to be exercised in the best interests of the debtor in possession and its creditors."); <u>In re Riodizio, Inc.</u>, 204 B.R. 417, 424 (Bankr. S.D.N.Y. 1997) ("debtor must demonstrate whether assumption or rejection confers a net benefit on the estate"); *In re Gucci*, 193 B.R. 411, 415 (S.D.N.Y. 1996).

- 21. A debtor's decision to assume an executory contract based on its business judgment will generally not be disturbed "absent a showing of bad faith or abuse of business discretion." In re Chipwich, Inc., 54 B.R. 427, 430-31 (Bankr. S.D.N.Y. 1985); see also In re G. Survivor Corp., 171 B.R. 755, 757 (Bankr. S.D.N.Y. 1994), aff'd John Forsyth Co., Inc. v. G. Licensing, Ltd., 187 B.R. 111 (S.D.N.Y. 1995). Upon finding that the debtor has exercised its sound business judgment in determining that the assumption of an agreement is in the best interests of the debtor, its creditors and all parties in interest, the court should approve the assumption under section 365(a) of the Bankruptcy Code. See, e.g., Gucci, 193 B.R. at 417; In re Child World, Inc., 142 B.R. 87, 89 (Bankr. S.D.N.Y. 1992).
- 22. To the extent that any of the Excess Aircraft or Potential Excess Aircraft is subleased by the Debtors to its regional carriers, the Debtors are also moving to reject the subleases of such Excess Aircraft. The rejection of a prime lease necessarily terminates the right to possession under the sublease. "This is so because the sublease depends upon the continuing viability of the prime lease, and the rejection of the prime lease also results in the rejection of the sublease." In re Child World, Inc., 142 B.R. 87, 98 (Bankr. S.D.N.Y. 1992); see also Rockefeller Group, Inc. v. I.S.H. Liquidating Corp. (In re 48th Street Steakhouse, Inc.), 835 F.2d 427 (2d Cir. 1987), cert. denied, 485 U.S. 1035 (1988) ("when a prime lease falls, so does the sublease");

<u>In re J.T. Moran Financial Corp.</u>, 124 B.R. 924, 925 (Bankr. S.D.N.Y. 1991) (same); <u>In re Shopper's Paradise, Inc.</u>, 8 B.R. 271, 275 (Bankr. S.D.N.Y. 1980) (same).]

As described above, the Debtors have determined that (i) the Excess Aircraft subject to leases no longer fit the business plan for the Debtors and (ii) the Potential Excess Aircraft subject to leases may no longer fit the business plan for the Debtors. The Debtors have also determined that the leases related to the leased Excess Aircraft are above the current market for similar aircraft and therefore have no value to the estates. Similarly, with respect to the leased Potential Excess Aircraft, the Debtors have determined that, under the existing lease terms, the leases are above the current market for similar aircraft and therefore have no value to the estates unless renegotiated. Therefore, each of the leases is a burden to the Debtors and is no longer beneficial. Accordingly, rejection of the leases would minimize the Debtors' post-petition obligations, would be in the best interests of the Debtors' estates, and represent a proper exercise of the Debtors' sound business judgment.

ABANDONMENT UNDER SECTION 544 OF THE BANKRUPTCY CODE IS IN THE BEST INTERESTS OF THE ESTATE

24. To the extent Excess Aircraft are owned subject to secured debt financings, the aircraft do not fit Debtors' business plan. Further, the liens against the owned Excess Aircraft exceed the market value of the aircraft, thereby leaving no equity for the estates. Consequently, such of the Excess Aircraft that is owned is burdensome and should be abandoned. Similarly, the Debtors have no equity in the owned Potential Excess Aircraft, under the existing debt terms. Consequently, the owned Potential Excess Aircraft are also burdensome to the estates. The abandonment will be "as is, where is," and the Debtors specifically make neither representation nor warranties regarding the abandoned owned Excess Aircraft and Potential Excess Aircraft.

25. Section 554 of the Bankruptcy Code provides:

After notice and a hearing, the trustee may abandon any property of the estate that is burdensome to the estate or that is of inconsequential value and benefit to the estate.

Section 554 thus requires two showings. First, the property to be abandoned must be property of the estate. 11 U.S.C. §§ 541 and 554. Second, the property to be abandoned must be burdensome or of inconsequential value or benefit to the debtor's estate. In re Grossinger's Assocs., 184 B.R. 429, 432 (Bankr. S.D.N.Y. 1995). Moreover, the debtor-in-possession is afforded significant discretion in determining the value and benefits of particular property for the purposes of the decision to abandon it. In re Interpictures Inc., 168 B.R. 526, 535 (Bankr. E.D.N.Y. 1994) ("abandonment is in the discretion of the trustee, bounded only by that of the court"). "Courts defer to the trustee's judgment and place the burden on the party opposing the abandonment to prove a benefit to the estate and an abuse of the trustee's discretion." In re Slack, 290 B.R. 282, 284 (Bankr. N.J. 2003).

26. The appropriate test in this case is whether the owned Excess Aircraft and Potential Excess Aircraft are burdensome or of inconsequential value to the Debtors' estates. In this case, because the owned Excess Aircraft are not required under the Debtors's business plan and the Debtors do not have any equity in the owned Excess Aircraft, the owned Excess Aircraft are burdensome to the Debtors' estates. This assessment reflects a business judgment made in good faith by the Debtors. Abandonment of the owned Excess Aircraft is, therefore, in the best interests of the Debtors' estates and a proper exercise of the Debtors' sound business judgment. By the same token, the Debtors have made a business judgment that the owned Potential Excess Aircraft, under existing debt terms, are burdensome to the Debtors' estates. Abandonment is, thus, also in the best interests of the Debtors, unless the debt terms can be revised. Similar relief

has been granted in other airline cases under similar circumstances. See, e.g., U.S. Airways Group, Inc., Case No. 02-83984 (Bankr. E.D. Va. August 12, 2002).

WAIVER OF MEMORANDUM OF LAW

27. This Motion does not raise any novel issues of law and is otherwise supported by citations to authorities. Accordingly, the Debtors respectfully request that the Court waive the requirement contained in Rule 9013-1(b) of the Local Bankruptcy Rules for the Southern District that a separate memorandum of law be submitted.

NOTICE

28. Notice of this Motion has been given to (i) the lessors and lenders having direct interests in the Excess Aircraft and Potential Excess Aircraft; (ii) the Debtors' twenty largest unsecured creditors; (iii) the Debtors' five largest pre-petition secured lenders or any agent therefor (iv) the United States Trustee for this District; and (v) the Securities and Exchange Commission. No trustee, examiner or creditors' committee has been appointed in these cases. In light of the nature of the relief requested, the Debtors submit that no further notice need be given.

NO PRIOR REQUEST

29. No previous motion for the relief sought herein has been made to this or to any other court.

WHEREFORE, the Debtors request entry of the attached Proposed Order granting the relief requested herein and such other and further relief as may be just and proper.

ORDERED that the Motion is granted and approved in all respects; and it is further

ORDERED that, pursuant to section 544 of the Bankruptcy Code, (as and to the extent applicable), and subject to the terms of this Order, the Debtors are hereby authorized to abandon, effective as of the Petition Date, the aircraft identified on Exhibit 1 that is owned; and it is further

ORDERED that the Debtors are authorized to maintain the current insurance coverage on the aircraft identified on Exhibit 1 and maintain the storage maintenance program under which any such aircraft is being maintained for the shorter of the following periods (such period, the "Excess Aircraft Coverage Period"): (a) the thirtieth (30th) day after the Petition Date, and (b) the date in which the lessor or lender, as the case may be, takes possession of such

ORDERED that, pursuant to section 365 of the Bankruptcy Code, (as and to the extent applicable), and subject to the terms of this Order, the leases for the aircraft identified on Exhibit 2 hereto are hereby rejected as of the date the Debtors file a notice of rejection with the Court, which notice will be filed not later than 45 days from the petition date; and it is further

ORDERED that, pursuant to section 544 of the Bankruptcy Code, (as and to the extent applicable), and subject to the terms of this Order, the Debtors are hereby authorized to abandon, effective as of the date the Debtors file a notice of abandonment with the Court, which notice will be filed not later than 45 days from the petition date, the aircraft identified on Exhibit 2 that is owned; and it is further

ORDERED that the Debtors are authorized to maintain the current insurance coverage on the aircraft identified on Exhibit 2 and maintain the storage maintenance program under which any such aircraft is being maintained for the shorter of the following periods (such period, the "Potential Excess Aircraft Coverage Period"): (a) the thirtieth (30th) day after the notice to reject or the notice to abandon, as applicable, is filed with the Court, and (b) the date in which the lessor or lender, as the case may be, takes possession of such aircraft and equipment. At the conclusion of the Potential Excess Aircraft Coverage Period, the Debtors shall cease insuring and maintaining such Potential Excess Aircraft; and it is further

ORDERED that the Debtors are authorized to reject any subleases related to any leases rejected pursuant to this Order; and it is further

ORDERED that notwithstanding the possible applicability of Bankruptcy Rules 6007, 7062, 9014, any other provision of the Bankruptcy Rules, Bankruptcy Code or otherwise, this Order shall take effect immediately upon signature by this Court; and it is further
